GENERAL CONTEXT

The Paris Agreement (PA) was adopted at COP21 in Paris on December 12th, 2015 with the goal of accelerating the global response to climate change.

The agreement commits all Parties to accelerate their transition to a low-carbon, climate-resilient economy, with the goal of containing global warming to no more than 2°C (or even 1.5°C) above pre-industrial levels.

In order to achieve this goal, the Paris Agreement established several mechanisms to ensure improved climate ambition, including primarily the Determined Contributions (NDC), and Low Carbon Development Strategies (LCDS) to 2050.

Tunisia ratified the Paris Climate Agreement by Organic Law No. 2016-72 of October 31, 2016 and submitted its first Nationally Determined Contribution (INDC) on September 16, 2015 and in accordance with the provisions of Article 3 of the Paris Agreement, updated it in October 2021, highlighting the importance of a transition to a new development model that is inclusive and aligned with the Sustainable Development Goals (SDGs).

Tunisia's updated NDC aims at a radical paradigm shift in all economic sectors, through:

- Reducing the carbon intensity of the national economy by 45% by 2030, compared to the base year 2010,
- Strengthening Tunisia's resilience to climate change by significantly reducing the vulnerability of its ecosystems, its population, its territories and its economy in a sustainable development and a green, blue circular economy.

The implementation of the updated NDC requires the mobilization of significant financial resources, estimated at approximately US\$19.4 billion over the period 2021-2030, including US\$14.4 billion for mitigation, US\$4.3 billion for adaptation and US\$0.7 billion for capacity building.

In order to mobilize the technical and financial support needed to implement the NDC objectives, Tunisia joined in 2017 the NDC Partnership global alliance launched at COP22 in 2016.

The NDC Partnership supports developing countries in their efforts to integrate climate change considerations into their development plans, sectoral policies, and national financial systems.

The NDC Partnership responds flexibly to the needs identified by countries and provides ongoing assistance, coordinating efforts to ensure that resources from countries and institutions complement each other and are used effectively to provide specific, responsive, and robust support measures. The NDC Partnership mobilizes technical and financial assistance, building state capacity through knowledge exchange to support the implementation of NDCs.

Governments benefit from the resources and expertise of a large range of partners, each bringing unique assets.

As part of its memberships to the NDC Partnership, Tunisia has taken a series of actions to mobilize additional financial and technical resources for the effective implementation of its Nationally Determined Contribution (NDC). Thus, the development of a partnership plan has allowed to prioritize the national needs at the sector level but also to identify a portfolio of mature and bankable projects contributing to the goal of achieving carbon neutrality by 2050.

In order to continue its effort to concretize the NDC of Tunisia, the Ministry of the Environment organizes on May 25 and 26, 2023 in Tunis, in collaboration with the NDC Partnership and the support of the UNDP and the GIZ, an international conference of the investment for the implementation of NDC in Tunisia, including the presentation of some sectoral priority projects, selected in consultation with the main public actors.

This conference, which will be held with the participation of many representatives of cooperation organizations, members of the NDC Partnership, at the international, regional and national levels, will be an opportunity to establish a climate conducive to investment promoting the mobilization of financial flows necessary for the implementation of the NDC and the operationalization of the Partnership Plan..

OBJECTIVES OF THE CONFERENCE

The Conference has the following objectives :

- Expose and discuss the main priority orientations in the Tunisian NDC, allowing the paradigm shift towards a sustainable, inclusive and decarbonized development
- Present the priority projects of the NDC, in the field of mitigation of greenhouse gas emissions and climate risk reduction, taking into account the specific vulnerability of Tunisia
- Engage in discussions with the partners of the NDC Partnership alliance, in order to better mobilize the means to support the implementation of the NDC, and to build relationships of continuous cooperation between national actors as well as technical and financial partners around the proposed priority projects.

- Presentation and discussion sessions on the priorities of Tunisia's NDC and the operational modalities of its implementation,
